The circumstances giving rise to the change in the percentage level from *26.00% to **25.99% are as follow:

During the period from 28 October 2010 to 8 November 2010, there was a series of transactions by subsidiaries of DBS Group Holdings Limited ("DBSH").

DBSH is an associated company of Temasek. Accordingly, as of 8 November 2010, Temasek has a total interest in 499,403,102 Shares (**25.99%) comprising the following Shares:

(i) 4,748,102 Shares (**0.25%) in which DBSH has an interest;

(ii) 655,000 Shares (**0.03%) in which Fullerton Fund Management Company Limited ("FFMC") as investment manager has an interest. FFMC is an indirect wholly owned subsidiary of Temasek; and

(iii) 494,000,000 Shares (**25.71%) held by Singapore Telecommunications Limited ("SingTel"). SingTel is a subsidiary of Temasek.

Temasek became aware of the change in percentage level of its interest in the Shares on 10 November 2010.
