Accordingly, as of 9 November 2010, Temasek has a total interest in 499,824,102 Shares (**26.01%) comprising the following Shares:</p> <p>(i) 5,169,102 Shares (**0.27%) in which DBSH has an interest;</p> <p>(ii) 655,000 Shares (**0.03%) in which Fullerton Fund Management Company Limited ("FFMC") as investment manager has an interest. FFMC is an indirect wholly owned subsidiary of Temasek; and</p> <p>(iii) 494,000,000 Shares (**25.71%) held by Singapore Telecommunications Limited ("SingTel"). SingTel is a subsidiary of Temasek.</p> <p>Temasek became aware of the change in percentage level of its interest in the Shares on 11 November 2010.</p>
