# Please specify details	<p>The circumstances giving rise to the change in the percentage level from *26.02% to **25.98% are as follow:</p> <p>On 15 September 2010, a subsidiary of DBS Group Holdings Limited ("DBS") sold 615,000 ordinary shares of the listed company ("Shares") which reduced DBS' deemed interest to 4,409,742 shares (**0.23%).</p> <p>In addition, Fullerton Fund Management Company Limited ("FFMC") continues to have an interest in 655,000 Shares and Singapore Telecommunications Limited ("SingTel") continues to own 494,000,000 Shares.</p> <p>FFMC and SingTel are subsidiaries of Temasek. DBS is an associated company of Temasek. By virtue of section 7(4A) of the Companies Act, Temasek is deemed to have interest in the Shares in which FFMC, SingTel and DBS have interests.</p> <p>Accordingly, as at 15 September 2010, Temasek has a total interest in 499,064,742 Shares (**25.98%) being all the 4,409,742 Shares (**0.23%) in which DBS has interest, the 655,000 Shares (**0.03%) in which FFMC has interest and the 494,000,000 Shares (**25.72%) held by SingTel.</p> <p>Temasek became aware of the change in percentage level of its interest in the Shares on 15 September 2010.</p>
