		There was a series of transactions by subsidiaries of DBS Group Holdings Limited ("DBSH") which increased their aggregate interest to 4,992,102 Shares (**0.26%) on 17 February 2011. DBSH is an associated company of Temasek.	
		In addition, on 17 February 2011, Singapore Telecommunications Limited ("SingTel") held 494,000,000 Shares (25.71%) and Fullerton Fund Management Company Limited ("FFMC") as investment manager had an interest in 655,000 Shares (0.03%). SingTel and FFMC are subsidiaries of Temasek.	
		By virtue of section 7(4A) of the Companies Act, Temasek is deemed to have an interest in the Shares in which DBSH, SingTel and FFMC have interests.	
		Accordingly, as of 17 February 2011, Temasek had an interest in 499,647,102 Shares (**26.00%) comprising the 4,992,102 Shares (**0.26%) in which DBSH had an interest, the 655,000 Shares (**0.03%) in which FFMC had an interest, and the 494,000,000 Shares (**25.71%) held by SingTel.
