On 28 May 2014, Singapore Post Limited ("SingPost") entered into an investment agreement with Alibaba Investment Limited ("Alibaba Investment"), pursuant to which SingPost will issue and transfer an aggregate of 220,096,000 ordinary shares in SingPost ("Shares") to Alibaba Investment, which consists of 190,096,000 new Shares and 30,000,000 existing Shares held in treasury by SingPost (the "Proposed Issuance").

On 31 July 2014, completion of the Proposed Issuance took place. Accordingly, Alibaba Investment now holds a direct interest in 220,096,000 Shares. As of 31 July 2014, Alibaba Group Holding Limited ("Alibaba Group") holds more than 50% of the shares of Alibaba Investment and SoftBank Corp. ("SoftBank") holds more than 20% of the shares of Alibaba Group. By virtue of this, SoftBank has a deemed interest in 220,096,000 Shares, representing approximately 10.32% of the issued share capital of SingPost (based on company announcement (reference SG140731OTHRV9QF) dated 31 July 2014 released by SingPost via SGXNET).
